By purchasing tickets to the CAHSA Homeschool Formal Prom,

• I affirm that I have read, understood and agree to abide by the following:

- ◊ Students must comply with the instructions from chaperones.
- ◊ Students should exercise careful use of the facility.
- ◊ Early dismissal allowed only with a parent's written permission or presence; no in-and-out privileges.
- ◊ Public displays of affection are discouraged.
- ◊ Modesty in dancing will be expected; no juking, freaking, or other "dirty" dancing, please.
- ◊ Weapons, alcohol, tobacco products, or illegal substances are not allowed.
- ◊ No one exhibiting the effects of alcohol or drug use will be allowed to enter.
- ◊ Foul language is unacceptable.

- I accept that students who behave inappropriately will be asked to leave; those who are refused entry or are dismissed due to inappropriate behavior are not entitled to any refund or reimbursement.
- I promise to make modest choices regarding my attire and interaction with others at the event.
- Furthermore, if I will be providing my own transportation, I vow to drive responsibly to and from the event and not participate in any illicit, illegal, or improper actions en route.

Accident Waiver and Release of Liability:

I acknowledge that the CAHSA Homeschool Formal Prom planned by the parent-volunteer Committee, in collaboration with the Crossroads Area Home School Association, is an event that involves risks. I hereby assume all risks associated with my participation in this event. I acknowledge that this form will be used by the sponsors and organizers of the event, and that it will govern my actions and responsibilities at the event, including my travel to and from the event. I hereby take action for myself, my executors, and successors as follows:

- A. Waive, release and discharge the Homeschool Formal Prom Committee, CAHSA and the Town of Normal, from any and all liability, loss and cost, claim, damage and cause of action of any kind, and
- B. Indemnify and hold harmless the entities or persons mentioned in this paragraph from any and all such liabilities or claims made as a result of participation in this event.
- C. I hereby consent to receive medical treatment, that which may be deemed advisable, in the event of injury, accident or illness during this event, following any attempt to reach my emergency contact.
- D. I understand that I may be photographed at this event. I agree to allow my photo to be used for any legitimate purpose by the event holders.
